## **Course Description**

The 5-kilometer (3.5 mile) race starts at Fairmont Elementary School, through the hills of Yorba Linda and ends at Esperanza High School. The route is hilly initially but ends flat.

## **Entry Fee**

\$40 Adults, \$20 Students and Military with I.D. during pre-registration until Saturday, June 13<sup>th</sup>, 2020, \$45 postentry and on race day. Children under the age of 12 are free. T-shirts to the first 800 participants. Entry fee is non-refundable. Proceeds benefit the Rick Centanni Memorial Fund and The Kaila Cottle Trust in Memory of Robert J. Cottle.

#### EVENT RULES & GUIDELINES APPLICABLE TO ALL PARTICIPANTS

The following event rules and guidelines are intended to help produce an event, to ensure the safety of all participants, to meet the requirements of local government permits. The Rick Centanni Memorial Fund retains the right to refuse entry to anyone declaring false information on their application, not making the required payment, or otherwise failing to meet the entry requirements. In any and all circumstances The Rick Centanni Memorial Fund retains the right to refuse entry to any person.

#### TERMS AND CONDITIONS OF ENTRY

#### **PARTICIPATION**

To register for the Centanni-Cottle Memorial 5k Run and Walk you must be 16 years of age or older on event day. Entrants aged 0 to 15 must be entered by a parent/guardian and must be accompanied at the event by a parent/guardian.

Each participant must agree to the disclaimer and these terms and conditions before participating in the event. All participants take part at their own risk and a disclaimer waiving all claims against The Rick Centanni Memorial Fund and any party acting on its behalf must be completed by all entrants. Registrants must be capable of completing the full distance, start line to finish line.

By taking part, all participants confirm that they are happy for their names and any footage or photographs taken during their participation in the Centanni-Cottle Memorial 5k to be used to publicize any Rick Centanni Memorial Fund event. Participant run number bibs are specific personal identifiers and cannot be exchanged with or sold to any other person. Transfers between runners can only be done through the official website within the deadline of transfer displayed on the website.

All entry fees are non-refundable and cannot be deferred towards a future event. Entries are non-transferable. Registration closure is determined and announced when event participation reaches the established capacity or a pre-set date.

#### EVENT DAY

Participants must follow instructions as given from all event officials including race staff, volunteers, medical personnel, security officers and city officials throughout the duration of the event.

All participants are expected to conduct themselves in a professional and courteous manner during their participation in the event. This means, for example, that urinating or defecating anywhere on or near the course shall be strictly prohibited except in toilet facilities. Anyone violating this rule of conduct shall be disqualified from the event and will be asked to leave the course.

Every participant shall be provided with an event bib number, which shall be conspicuously worn on the front (and back when applicable) during the event. The event bib number is to be worn as issued. No participant shall be permitted to participate in the event without the appropriate bib number.

All participants must write their name and details of any health problems or medication on the reverse of the run number, which must be worn on the front of their shirt during the run.

Baby joggers, baby strollers and wheelchairs, where the course route safely allows, are permitted on the course. Participants must begin the event during the official recognized starting times and in the interest of safety should start from the back of the group.

All participants must acknowledge and agree that personal information (including medical information entered on their run number or collected by event medical staff during or after the Event) can be stored, used and disclosed by the Rick Centanni Memorial Fund in connection with the organization, promotion and administration of the Event and for the compilation of statistical information.

#### THE START

Participants shall assemble for the Big Warm Up, 20 minutes prior to the run starting. Participants shall then proceed to the start line. All participants must be positioned behind the starting line when starting.

#### **COURSE MONITORING**

Any participant who refuses to obey the directions of the event official, city official or course marshal, or who conducts himself/herself in an un-sportsman like manner, or who is offensive by action or language to officials, volunteers, participants or spectators may be disqualified by the event and future participation at the discretion of race officials. Any person who participates in the event without a current official event bib number not officially assigned to him/her is subject to removal and disqualification from future Rick Centanni Memorial Fund events.

No persons are authorized to be on the course unless they are registered participants - runners aged twelve and under get free entry but must be registered; there is a free entry category on the event entry system for this purpose. A person will be allowed to accompany a participant if the participant is not physically/mentally able complete the course alone.

#### PARTICIPANT SAFETY

Participants are responsible for their recognition and understanding of event signage, symbols and color relating to participant maps, facilities and direction.

Medical personnel authorized by the event to do so may examine any participant who appears in distress. If in the sole opinion of authorized medical personnel, it is in the best interest of the participant's health and welfare, medical personnel can remove the participant from the event. Participants must retire at once from the run if ordered to do so by a member of the event's official staff, official medical staff, or any governmental authority, including fire and police officers. Participants are responsible and assume liability for any and all medical expenses incurred as a result of training for and/or participation in the event, including but not limited to ambulance transport, hospital stays, physician and pharmaceutical goods and services.

Event officials reserve the right to delay, cancel, alter the route or suspend the event due to inclement weather in accordance with Emergency Protocol on severe emergencies and/or inclement weather. No refund will be issued in these circumstances.

#### PRIVACY POLICY

All customers agree to our privacy policy when they enter an event.

#### **EXCEPTION**

Any individual requesting a waiver of any of these rules from the event shall submit a written request no less than 30 days prior to the event date specifying the nature of and reasons for the request.

#### AMENDMENTS / RESERVATIONS / ACKNOWLEDGEMENTS

Event officials reserve the right, to modify, supplement or waive all or part of the event rules. Participants shall be bound by any modification or supplement of the event rules published prior to the event. Failure to follow these event rules, as can be amended, will result in immediate disqualification, loss of prize money and removal from official results.

#### **Cancellation Policy**

No cancellation or refunds will be issued once registration is complete.

#### DISCLAMER

In order to run in the Centanni-Cottle Memorial 5k Run and Walk, runners must agree the following disclaimer:

WARNING: READ CAREFULLY. THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND DEPRIVES YOU OF THE RIGHT TO SUE THE RICK CENTANNI MEMORIAL FUND AND THE KAILA COTTLE TRUST FUND

IN MEMORY of ROBERT J. COTTLE, dba "THE RICK CENTANNI MEMORIAL FUND AND THE KAILA COTTLE TRUST FUND IN MEMORY of ROBERT J. COTTLE" AND OTHER PARTIES. DO NOT ENTER INTO THIS AGREEMENT UNLESS YOU HAVE READ IT IN ITS ENTIRETY, SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT

"In completing this entry, I declare that I, or anyone that I am paying for, will not compete in the run unless medically fit to do so and that, in any event, we will compete at my/our own risk. I accept that the organizers will not be liable for any loss, damage, action, claim, costs or expenses which may arise in consequence of my/our participation of the event.

I also hereby give my permission to pass my/our details to my chosen charity and to use my/our name, quotes, video footage, and photographic likeness for marketing and promotional purposes. I also agree to the full Terms and Conditions as displayed on the event website.

COTTLE, its officers, agents, representatives, employees, subsidiaries, and contractors (collectively, "Released Parties") from all liabilities, claims, causes of action, or suits arising from or connected to my participation in any events for which I registered organized and sponsored by THE RICK CENTANNI MEMORIAL FUND AND THE KAILA COTTLE TRUST FUND IN MEMORY of ROBERT J.
